Official statement.

After having been forced, due to the state of alarm declared on March 15, to close our facilities on a mandatory basis. We apologize for the inconvenience caused to all our users. It seems that little by little we will be able to get back to being open. The return, as required by law, will have to be staggered for us and with hygiene and safety measures that will be mandatory and must be observed. In order to guarantee the health and well-being of the users of the centre.

At Denia Fitness Centre we are looking forward to being able to provide service to our members, from May 11 we will reopen our facilities.

The first phase of activity after this confinement is very strict in terms of standards and requires us to set conditions to be able to progressively provide service to all those who want to use the facilities.

We now go on to detail the steps to follow:

1. Attendance at the centre will be by appointment only By APP Ufit365.
2. All appointments will be 1 hour long. From 8:00 to 13:00 and from 16:00 to 20:00 from Monday to Friday.
3. The training areas will be limited to the weight room and the Spinning room (for virtual classes), all the others areas being closed to the public including changing rooms, showers, saunas and swimming pool.
4. The use of masks and gloves will be mandatory. (The centre will not provide this type of material to users). The booking will cancelled if the member is unable to turn up with these safety measures.
5. Temperature controls and a disinfection checks will be carried out in the reception area. Before access to the training areas. The use of a towel in the training areas will be mandatory. Canceling the appointment if the user ignores these rules.
6. The user will be responsible for disinfecting the material before and after use. The centre will provide disinfectants and paper for this purpose.
7. Street shoes will not be accepted for training, footwear to be used in the facilities will be disinfected in the check in area. The change of footwear will be made in the reception area, leaving the street shoes in the reception area.

8. All those with the month of March subscription paid for will have priority of reservation.
9. Personal training service will be available with an additional charge, if required. The service will be requested together with the appointment.
10. Contact between people within each authorized area will not be allowed, and it is mandatory to respect the safety distance of 2 meters between users.
11. Denia Fitness Centre reserves the right to change any of the points of these rules in case of need to adapt them to the changing circumstances of the extraordinary situation.

We know and understand that these are very strict and restrictive standards, but that in the times in which we are living and the new reality that we must face, it forces us to, for the moment, be everything in our hands and from the best of wills. , we can offer our subscribers to gradually return to enjoy physical activity in our facilities.

For all those who still do not feel comfortable to start using the facilities with the obligations described above and having paid in March, Denia fitness centre agrees to keep the status of their subscription frozen until the user decides to do use of when measures are more appropriate for the use of facilities with less restrictions and as a maximum period until the alarm state is lifted. The refund of the current subscription is not contemplated in any case.
